



Special Events Agreement Form

- 1) Sponsor agrees to provide Carolina Tiger Rescue with all of the net proceeds from the Event within 30 days after the event. If over \$500 is raised, a written accounting of Event revenues and expenses should also be provided.
- 2) Sponsor may use Carolina Tiger Rescue's logo with the prior written approval. Accordingly, Sponsor agrees to submit to Carolina Tiger Rescue for approval – prior to the production and/or distribution of all printed materials, publicity releases and advertising relating to the Event that mentions Carolina Tiger Rescue.
- 3) Sponsor understands and agrees that the Logo: (a) may not be altered in any way and (b) may only be used if in conjunction with our positions and values (see website).
- 4) In accordance with standards adopted by the BBB Wise Giving Alliance, Sponsor agrees that any solicitations relating to the Event must specify at the point of solicitation, and in a manner acceptable to Carolina Tiger Rescue: (a) that Carolina Tiger Rescue is the benefiting organization; (b) the actual or anticipated portion of the purchase price that will benefit Carolina Tiger Rescue.
- 5) In order to avoid inadvertently jeopardizing existing relationships between Carolina Tiger Rescue and its donors, Sponsor agrees to receive approval from Carolina Tiger Rescue before soliciting corporations, businesses, celebrities, sports teams, or individuals for cash or in-kind donations relating to the Event.
- 6) Sponsor represents to Carolina Tiger Rescue that: (a) it will comply with all applicable laws during the planning, promotion and conduct of the Event; (b) all necessary insurance, licenses and permits will be obtained and will be in force through the conclusion of the Event; (c) the Event will result in no cost or expense to Carolina Tiger Rescue whatsoever, unless expressly agreed in writing to the contrary; and (d) it will indemnify and hold Carolina Tiger Rescue harmless from any and all claims of any kind or nature whatsoever arising out of, or in any way related to, the Event.
- 7) Nothing in this document shall be construed to authorize Sponsor, or any of its employees or representatives, to act as an agent of Carolina Tiger Rescue. Thus, for example, Sponsor may not open a bank account in Carolina Tiger Rescue's name, nor may it endorse or attempt to negotiate any checks made payable to Carolina Tiger Rescue, all of which must be promptly forwarded to Carolina Tiger Rescue for processing.
